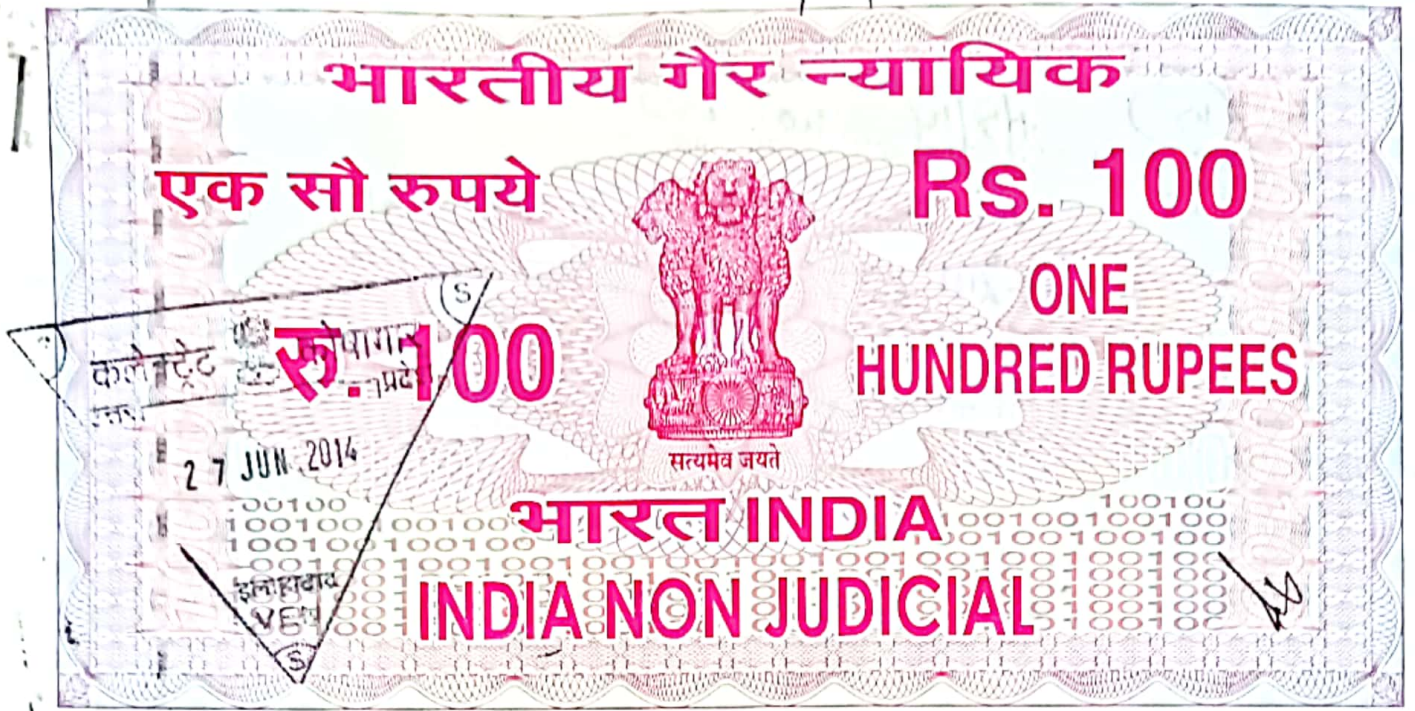

1. The Name of the trust shall be "OM SHRI SIDDHIVINAYAK FOUNDATION" with its registered office at A-112 Mehndouri Colony Teliyarganj Allahabad, Uttar-Pradesh
2. The total no. of trustees shall at no time exceed eight and initially the board of trustees (herein after called the "BOARD" which expression is used co terminus with "TRUSTEES") SHALL BE AS UNDER:-
 - Smt. Mamta Tiwari aged about 42 years, W/o Shri. T.S. Tiwari, Resident A-112 Mehndouri-Colony Allahabad Uttar -Pradesh
 - Mr. Ravi Mohan Ojha aged about 35 years, S/o (Late) Shri Kartar Nath Ojha, Resident of New Babaganj Colony, Pratapgarh, Uttar-Pradesh.

3. The remaining trustees may be appointed by nomination by the five trustees who are known hereinafter as "FOUNDER TRUSTEES" and the said five trustees can be the life members of the trust or their membership can be finished on behalf of their uninterested attitude or non supportive attitude to the TRUST or as the decision by the CHIEF FOUNDER TRUSTEE\SECRETARY due to circumstances.

The remaining trustees shall retire on the expiry of three years and the "FOUNDER-TRUSTEES" shall thereafter nominate substitute trustees whose period of tenure would be of three years from the date of nomination.

4. Any of the "FOUNDER TRUSTEES" except the Secretary shall have no power to nominate a person as his\her successor and in case he\she leaves any such nomination, only the "SECRETARY & FOUNDER TRUSTEES" shall have the right to fill up the vacancies. The "FOUNDER TRUSTEES" would or may act as trustees for their whole span of life without any nomination of their successor or nominee.

5. It would be open for the trustee to be board of trust after his\her period lapse in the manner provided above.

6. The said trustees have accepted the initial sum of money to be held by them in the above-mentioned trust.

7. The trustees have agreed to act as TRUSTEES and to hold the said sum of rupees 2100.00 (Rupees Two Thousand One Hundred Only) and the investment for the time being representing the same and all other sums or properties and assets which may from time to time form part of the trust fund for such purposes as are hereinafter.

8. The trust fund shall be applied or utilized in entire INDIA for charitable purposes relating to providing against natural disasters and many more humanity needs to any N.G.O or TRUST without any personal interest or adding any profit, except in the course of the actual carrying out of a primary purpose of the trust.

9. The trustees shall have full power to acquire the trust properties by lease, sale or instrument or fresh construction augment the income of the trust. It would be open for the trustees to enter into any negotiations and transaction for the financial betterment of the trust. The trustees shall have full power to apply the income and the properties of the trust for the aforesaid purpose without any distinction or discrimination on account of caste, creed, community or sex and they shall utilize the trust properties and funds as accordingly as below:-

a)- To create, establish and maintain as a first activity an institute called the "OM SHRI SIDDHIVINAYAK FOUNDATION".

b)- To cooperate with other societies, institutions and organization in the pursuit of all or any of the above objects.





c)-To takeover manage or combine whether by affiliation or otherwise with any other institution for the furtherance of all or any of the above objects.

d)-To publish for distribution and sale study reports, treatises, book, periodicals, reports, journals and literature relating to the above objects provided that the activities of this nature shall be undertaken on no-profit basis.

e)-To constitute or caused to be constituted regional offices at convenient centers for advancing and to help the efficient execution of its activities.

10. The trustees shall cause true and accurate accounts to be kept of all moneys received and disbursed or spent and of all matters in course of management of trust properties or in respect there of or in relation to the carrying out of the objectives and purposes of the trust as well as of all the assets, liabilities and effects of the trust properties. The trust account will be audited by a chartered Accountant every year.

11. The trustees may in their discretion accept any loan, donation or contribution in cash or kind from any person for the furtherance of the objects of the trust or any one or more of them.

12. The trustees may invest the trust funds within the ambit of section 11 to the section 13 of the Indian income Tax Act.1961 either in the purchases or mortgage of immovable properties or shares, stocks or debentures of any company or in such investments or by way of deposits with or loans to any company , bank firm or otherwise on such terms and condition as the trustees may think proper with the to the trustees to alter, vary or transpose such investment from time to time in such manner as they may in their discretion deem fit, within above noted ambit .All the investment of the trust may remain in the name of one or more of trustees as the board may decide and the persons in whose names the investment are so held shall exercise all power, rights and obligations in the respect of the said investments subject to control and direction of the board.

13. The trustees may open current or saving account in the name of the trust with any nationalized bank, firm company or other institution on such terms and conditions as they may deem fit and authorize one or more of the trustees or any other persons to such conditions as the board may decide from time to time.

14. The trustees shall have the power to appoint officer and servants for various posts of the trust and the trustees may also give such powers to any person as may be necessary for carrying out the directions of the trustees for managing the trust properties and its affairs, on such term and condition as the trustees may decide from time to time.

15. If there be any vacancy due to a trustees resignation or demise or for any other such resign the vacancy shall be filled up by nomination by the five founder trustees or their successors-in-office.

16. The trustees shall be chargeable only for such moneys, stocks, shares and funds as actually come into their respective and shall not be answerable or accountable for negligence, default as act of commission or commission of the other trustees nor of any bank or other person with



whom the trust's properties or securities may have been deposited or handed- over by them in connection with the management of the affairs or carrying out the objects the trust.

17. The board may authorize a person to issue receipt for any money paid or any property transferred or delivered to the trustees and the said receipt shall effectually discharged any person so paying or transferring or delivering.

18. The trustees will not be entitled to receive any remuneration as Trustees but may reimburse themselves of all expenses actually incurred by them in connection with the administration of the trust or their duties relating thereto, this including reasonable monthly conveyance and telephone allowance as the BOARD may decide for such trustees using their personal transport and phone for attending the trust duties.

19. The trustees may from time to time frame rules for the conduct of the affairs of the trust and for regulating the meeting of the Trustees. However, in the absence of any such regulations to the contrary:

A)- All matters will be decided by the majority in the Trustees meetings;

B)- Three Trustees shall form quorum for the meetings of the trustees;

C)- Resolutions passed without any meeting of the trustees and evidenced in writing under the hands three-fourths of the board shall be as valid and effective as a resolution duly passed at a meeting of the Trustees.

20. It is expressly declared that no part of the trust property or its income shall be applied for the purpose and all the powers and provisions of this instrument shall be constructed as such.

21. It is also expressly declared that no part of the income or Assets of the Trust shall be used or applied for the trustees or members of their families and relations within the meaning of section 13 of the Indian Income Tax Act, 1961.

22. The Chief Founder Trustee & secretary of the Trust shall have the special power to absorb the power of other trustee\trustees or may cancel their membership of the Board or Trust. *After the Secretary is no more in this world or may leave his designation due to bad health or any other circumstances in such position the lonely nominee & successor of his MASTER AKSHAT OJHA (SON) shall have the veto power to handle the Trust and occupy the position of the secretary.* It is expressly declared that we authorize **Mr. Ravi Mohan Ojha** to sign this document and have it dully registered on our behalf.

23. No immovable property is attached with this Trust Deed. In witness whereof the authorized nominee of the parties hereto has hereunto set and subscribed his hands the day, month and year first above written.

Few laws of the Trust were inadvertently left to be incorporated. The BOARD of the Trustees has decided to enlarge the scope of the objects and activity of the Trust as such the following provisions:

- TO organize cultural, educational and other education on no profit basis for the poor communities.
- To fight and prepare the people against 'CHILD LABOUR' and to prevent any injustice to them.
- To co-operate with the Government and also the Army in matters of national security to make our Nation very strong and powerful because unless the Nation is secured we can't be secured.
- Our effort is to make the dream true of Lal Bahadur Shastri "JAI JAWAN JAI KISAN". We want to give our best services in the various fields of cropping & cultivation.
- To create an awakening in farmer to manufacture and use JAIVIC FERTILIZERS such as UREA etc or pesticides which damages the land and also cause many diseases for this purpose promotion of Dairy-Farming is to propagate at priority.

- All the payments, may be of O.P.D, medicinal, tests, operation, delivery, chemotherapy, radiation, surgical item purchase or anything else will not be accepted by cash.
- Any type of stock variation will be deducted from the salary of counter manager.
- Patient's attainers will be allowed to meet the patient only having the attainers meet card, nobody else will be allowed or permitted except that one.
- Ambulance charges will be deposited advance (for other District\State).
- Ambulance charges for local (within 25 KM) will be free.
- Doctors for special care in ambulance (if required) will be extra paid by the patient in advance.
- Any return of medicine will not be accepted without bill or within three days.
- For blood (in use of hospital purpose) the attainers have to arrange donors to exchange the blood unit from the blood bank and 800.00 (Eight Hundred Rupees) or applicable amt. at the moment as for hospital norms and conditions along with the sample demand documents of the particular hospital or nursing home.
- Any extra obligation will not be provided to the staff, if anybody is caught immediately will be kicked out.
- The attainers of the patient will be allowed only one hour in morning and the same in evening.
- The meeting time will be 7:30 to 8:30 A.M and 6:00 to 7:00 P.M.
- After the meeting time ends the attainers will be announced to have the demand notes (of medicine\surgical\IPD required or payment dues) by the super wiser of individual facality through the main counter.

- No attainer shall be allowed to stay in hospital either in morning or evening after the meeting time is over.
- No attainer will be allowed to smoke, drink or chew gutka etc in hospital campus.
- No bargaining will be entertained; the patient and his attainers shall have to pay the announced and declared fee\charges.
- The B.P.L CARD HOLDERS will be benefitted only if they show their registered card by the signature of Authorized Signatory.
- The hospital will select and enroll at least 50 people every month for the benefit of B.P.L CARD.
- The B.P.L CARD CREDITORS have to bring their card every time to get the benefit.
- The entire staff will be entertained free but have to pay medicinal or surgical purchase by themselves.
- All the medical facilities and small surgeries will be free for the staff, committee or board members but in case of big and expensive surgeries the staff has to pay minimum charges decided by the BOARD.
